Navantia is committed to providing **safe and healthy working conditions** for the prevention of injuries and health deterioration, as well as the **protection of the environment** and the fight against **climate change**, as elements of strategic importance and as the first criterion to be taken into account since the beginning of the planning and during the development of all its activities. It is also committed to leading actions aimed at eliminating hazards and reducing risks in the work environment and in all its processes, providing the necessary resources for the maintenance and **continuous improvement** of the management systems, thereby pursuing the **goal ZERO ACCIDENTS**.

The existing environmental aspects and their associated risks are identified and assessed, carrying out control over the most significant ones to avoid or reduce the possible impacts that our activities may cause, establishing **systems for verification and assessment** of the degree of compliance. **Reduction** and **compensation of greenhouse gas emissions** and the **protection of the marine environment** are priorities.

The responsibility for the prevention of occupational risks and the environment must be **a commitment and a value**, both **individually** and in terms of the position they hold, for **each** and **every** worker, either from the company or subcontracted ones, **integrating** preventive and environmental actions into all their **activities and decisions**.

Therefore, Navantia is committed to develop, implement, maintain and certify by external **accredited certification** entities, the Quality Management Systems (according to standards and/or publications AQAP 2110, 2210, 2310, EN ISO 9001:2015, EN 9100:2018), Occupational Health and Safety (according to ISO 45001:2018), and Environmental Management (according to ISO 14001:2015), as well as verifying annually its carbon footprint (according to ISO 14064).

The **top management** shows its permanent **commitment** with this Policy and, in particular, through the monitoring and periodic review of the Management Systems, ensuring their continuous adaptation to the Vision, Mission and Values of the Company, taking into account the needs and expectations of the interested parties. Objectives are defined, measurable and consistent with the principles herein established, which are broadly spread and monitored to ensure their implementation and effectiveness.
