#### Purpose of the processing

Purpose: The data collected will be processed to preserve both the security of the persons, property and facilities of NAVANTIA.

#### Terms for data retention

Images captured by video surveillance systems will be stored for a maximum period of one month from their capture, unless they must be stored to prove the commission of acts that infringe the integrity of persons, property or facilities.

#### Legal basis

The legal basis for processing is based on GDPR Article 6(1)(e): the processing is necessary for the fulfilment of a mission carried out for the public interest or in the exercise of public powers conferred on the data controller.

#### Recipients

Communication of the images to the Security Forces and to the Courts is envisaged. No transfers to third countries or international organisations are envisaged, except by legal obligation.

#### Rights

Personal rights of those concerned are:

- ✿ Obtain confirmation as to whether Navantia is processing their personal information.
- ✿ Access their personal data, and request erasure when, among other reasons, such data are no longer needed for the purpose they were collected.

- ♣ Request under certain circumstances:
  - Restriction on the processing of your data, in which case they will only be stored by Navantia for the filing or defence of claims.
  - Objection to the processing of your data, in which case Navantia will cease to process the data, except for compelling legitimate reasons, or the filing or defence of possible claims. Your data may also be processed for automated individual decisions.
  - Portability of the data to be provided to the data subject or transferred to another controller, in a structured, commonly used and machine-readable format.
